1. Procedure for submission of application:

All eligible candidates, willing to take part in the above-mentioned LDCE must apply in the prescribed from **(ANNEXURE-B)**, duly completed along with necessary documents.

2. Place of Posting: The place of posting will only be at ICMR-NIIRNCD, Jodhpur. However, the post carries all India transfer liability. The selected candidates may be posted at any of the institute/centres under the control of ICMR and at any field units of the NIIRNCD located in different parts of the country.

3. General Instructions to candidates:

- i. Crucial date for determining the eligibility is 26.09.2025.
- ii. The selection in above posts as advertised will be made as per the provisions mentioned in 'ICMR Administrative Recruitment Rules, 2017' and subsequent amendments.
- iii. Incomplete or wrongly filled application form will be summarily rejected and no communication in this regard will be entertained.
- iv. Reservation and relaxation shall be applicable as per the Govt. of India rules.

A. Scheme of Examination: The subjects of the Written Examination and the maximum marks for each subject will be as follows:-

PART B: SHORTHAND SKILL TEST (50 MARKS)

- i) Question paper will be of Objective Type Multiple Choice only.
- ii) The examination will be in Pen and Paper mode.
- iii) There will be no negative marking in the examination.
- iv) The question paper will be in English language only.
- v) Computation of marks from the Shorthand is essentially marked in terms of 0% mistakes. A universal criterion of 5% mistake is generally taken as cut-off for qualifying. But in this exam this has to be converted to marks. Therefore, 5% mistakes will be equated with 40% marks i.e. those who make 5% mistakes will be given 40% of 50 (20 marks). For every 1% less mistakes an additional 6 marks will be added to 20 in such a manner that those who make 0% mistake will get full marks (50).
