Office Circular

Sub: Implementation of directions of the Hon'ble Supreme Court in Suo Motu W.P. (C) No. 5 of 2025 regarding prevention of dog bites and effective management of stray dogs within the institute campus - reg.

In pursuance of the directions of the Hon'ble Supreme Court in Suo Motu W.P. (C) No.5 of 2025 and with the approval of the Competent Authority, the following instructions are hereby issued for strict compliance by the concerned Sections/Committees:

1. Maintenance Section:-

- Ensure that the boundary wall around the entire Institute premises is at least 6 feet in height, free from any gaps/holes, and the upper portion is properly secured with fencing, without any openings.
- Ensure that all entry gates and boundary walls are free from gaps or holes. Existing gaps, particularly on the front-side boundary wall, shall be covered on priority using appropriate steel nets. stray dogsmanagement
- Carry out regular inspections of boundary walls and undertake immediate repairs wherever breakages or holes are noticed.
- Designate a suitable feeding place outside the Institute Boundary wall.

2. Guest House Committee.

- Ensure that feeding of stray dogs is strictly prohibited in and around the New Guest House/Old Guest House and surrounding areas.

3. Swachhata Committee.

- Maintain cleanliness and hygiene across the Institute campus.
- Conduct regular inspections to identify areas prone to stray dog congregation.
- Take preventive measures to eliminate such vulnerable areas.

4. Security Agency.

- Ensure that all entry gates remain closed and are opened only under the supervision of security personnel.
- Allow entry only to authorised persons and prevent entry of stray dogs into the Institute premises.
