3. Role and responsibilities of Capital Works Advisory Committee:

- To advise Execution for planning and designing of capital works.
- To advise Execution Agency in the preparation of conceptual architectural drawings in respect of the work of construction of laboratory buildings and other infrastructure facility buildings.
- To assist Execution Agency in developing the conceptual architectural drawings into working architectural drawings.
- To give suggest for planning and designing of specialized laboratory buildings (Bio-safety buildings).
- To give recommendations regarding scope and specifications of capital works.
- To assist the Execution Agency in freezing the architectural planning of capital works.
- To monitor physical and financial progress and quality of the capital work.
- To give recommendations for release of advance funds to the Executing Agency based on physical progress of the capital works.
- To assist institute to take over the satisfactorily completed capital work.
